We, as the Zimbabwean diaspora, have written several petitions to the UK government {including the FCDO} and carried out various protests in the UK against the Zanu-PF regime in Zimbabwe. ## Recommendations

Our Petition regarding the Zimbabwe Elections held over 23-24<sup>th</sup> August 2023, Mismanaged by the highly partisan **Zimbabwe Electoral Commission** (ZEC). We are Seeking a new election supervised or directly controlled by SADC/AU or even the Commonwealth/UK/EU/USA

1. We are calling for a lasting solution to the Zimbabwean crisis through a re- run of the Zimbabwean harmonised elections under direct supervision by SADC , AU , the Commonwealth and the EU.
2. The Zimbabwean diaspora community is calling for no taxation without representation. This community is providing substantial liquidity to the Zimbabwean economy and must be allowed to vote. **“The Diaspora Vote”**
3. ZEC has failed dismally and must be disbanded. Never ever to preside over any elections in Zimbabwe.
4. The International community must put pressure on the Military Junta in Harare to implement the reforms recommended by the Montelathe Commision.
5. The Military, Judiciary and Police must not be involved in the country's politics, cease and desist from being partisan.
6. The TV/Newspaper/Media must not be involved in the country's politics and desist from being partisan.

## Zanu PF and Torture:

Over the years torture victims in Zimbabwe have suffered physical pain, as well as psychological trauma and post-traumatic stress disorder despite the prohibition of torture under customary international law and in the constitution. Zimbabwe is yet to ratify the UN Convention Against Torture and Other Cruel, Inhuman and Degrading Treatment or Punishment and is one of only three countries in Africa, including Sudan and Tanzania, that has not yet ratified this important international instrument calling on states to prevent the practice of torture

Zimbabwean authorities must end their crackdown against opposition and civil society members ahead of the Southern African Development Community (SADC) summit scheduled for 17 August 2024 in Harare, Amnesty International and Human Rights Watch said today. The authorities must immediately and unconditionally release everyone arrested for exercising their rights.

Authorities must also promptly and effectively investigate allegations of torture or other ill-treatment of detainees and hold any suspected perpetrators accountable in fair proceedings, the groups said. Further, SADC must urgently demand an end to this assault on human rights as it prepares to hand the bloc’s leadership to Zimbabwean President Emmerson Mnangagwa.

“Since mid-June, Zimbabwean authorities have conducted a massive crackdown on dissent. More than 160 people have been arrested so far including elected officials, opposition members, union leaders, students and journalists,” said Khanyo Farise, Amnesty International’s Deputy Regional Director for East and Southern Africa.

“Security forces have tear-gassed people in a private residence, beaten people so badly they needed hospitalization, forcibly disappeared people for hours and tortured people in custody. The authorities must stop committing such violations and immediately release all detainees.”

SADC leaders must condemn the Zimbabwe government’s human rights violations and demand that the authorities reverse course by releasing everyone unjustly arrested before the situation worsens further, the groups said. President João Lourenço of Angola, who is the SADC chairperson, and Zambian President Hakainde Hichilema, who chairs its Politics, Defense and Security Cooperation Organ, need to speak out.

#### **A wide-ranging crackdown**

The current crackdown began on 16 June, when police raided the home of the opposition Citizens Coalition for Change (CCC) party leader, Jameson Timba, during a private gathering and arrested 78

people. Police fired tear gas and beat people with batons, resulting in multiple injuries, including one requiring surgery.

The authorities charged the group with “gathering with intent to promote public violence and disorderly conduct” and held them for more than two days without bringing them before a court, in violation of Zimbabwean law. The authorities released two children and granted bail to one adult, but 75 people remain arbitrarily detained.

On 24 June, police arrested 44 members of the Zimbabwe National Students Union (ZINASU), including its president, Emmanuel Sitima, and forced them to pay fines for “disorderly conduct” before releasing them. Police then re-arrested Sitima for “criminal nuisance” before releasing him the next day on bail.

On 27 June, Zimbabwe President Mnangagwa warned against “opposition political parties bent on peddling falsehoods and instigating acts of civil disorder, especially before, during and after regional and world state events.” Hours later, police outside the Harare Magistrate’s Court beat and arrested peaceful protesters, who were demanding the release of the people arrested at Timba’s house.

The next day, Information Minister Jenfan Muswere threatened “elements within the opposition, certain politicians, and some civil society organizations,” saying that “their days are numbered.”

On 29 June, police arrested five members of the National Democratic Working Group social justice movement at a private home in Harare during a meeting to raise funds for impoverished families, then released them. On 1 July, the police broke up a memorial service for a CCC member killed in 2022. Police arrested another six people affiliated with the Community Voices Zimbabwe media organization in Gokwe on 3 July before releasing them without charge.

On 31 July, state agents pulled four activists off a plane before take-off at Robert Gabriel Mugabe Airport and forcibly disappeared them for nearly eight hours. Lawyers later documented evidence of torture and other ill-treatment, including extensive bruising on the Amalgamated Rural Teachers Union of Zimbabwe leader, Robson Chere, reportedly requiring urgent medical attention. The authorities charged the four activists with “disorderly conduct” for participating in the 27 June protest outside the Magistrate’s Court.

The authorities have arrested more than 30 people across Zimbabwe since 1 August, including Sitima for a third time, a parliamentarian and 13 others in Kariba town, a city council member, a senator and a religious leader. Most arrests were related to protests or supporting opposition parties. On 8 August, masked people attempted to break into the offices of the Crisis in Zimbabwe Coalition civil society organization in Harare.

“The serious violations we are witnessing, including violent attacks, abductions, torture, arbitrary arrests and other abuses against the opposition, government critics and activists are just the latest

example of the failure of President Mnangagwa’s government to promote, protect and respect basic human rights,” said Idriss Ali Nassah, senior Africa researcher at Human Rights Watch.

SADC has said nothing publicly about these human rights violations. The bloc needs to take a clear stand against the crackdown in Zimbabwe, especially as President Mnangagwa prepares to take over the SADC chairmanship, the groups said. The African Commission on Human and Peoples’ Rights should demand the immediate and unconditional release of everyone arbitrarily detained simply for exercising their rights.

“The Zimbabwe authorities’ intensified crackdown and the dismantling of fundamental freedoms is directly linked to the government’s hosting of the SADC summit in Harare,” Nassah said. “It sets a dangerous tone for the bloc’s commitment to human rights under the upcoming chairmanship of Zimbabwe President Mnangagwa.”

While SADC must address the clampdown in Zimbabwe now, it must also use the Harare summit and President Mnangagwa’s chairmanship to improve respect for human rights across the region, in line with the SADC treaty.

A STATEMENT ON THE CURRENT SITUATION

**9 AUGUST 2024**

"Hate What Is Evil; Cling to What Is Good" (Romans 12:9)

The Zimbabwe Catholic Bishops' Conference (ZCBC) notes with deep concern the prevailing situation in the country. We all are conscious of the Southern Africa Development Community (SADC) Heads of States meeting that is to take place beginning on the 17th of August 2024. It is in preparation for this important meeting that we are seeing the resurgence of some ugly vices. This is sad, for in a democratic nation that knows the value of human dignity, freedom of association and of speech, such vices have no place as they contradict some of the fundamental values that form the bedrock of our national Constitution.

Generally, people with grievances tend to take advantage of big meetings to air their views. We have seen people positioning themselves to do this in the past and are doing so now. This phenomenon is not unique to Zimbabwe. Governments often struggle to deal with such realities. Some tend to be

repressive, but such responses are self-defeating. As the Catholic Bishops we are worried and saddened that to silence the dissenting voices and to quell possible demonstrations violence, torture, and abductions seem to be the only options deployed. Why not try dialogue with those who feel aggrieved by the present state of our country?

As Zimbabweans we are people with a culture of tolerance, and we value diversity. Let this be seen in how we conduct our businesses and how we articulate our grievances. We appeal to all concerned, to exercise their rights responsibly and to the government we call for restraint. The prevailing situation in the country does no one any good. Recently, we have seen the wanton arrests of citizens under frivolous charges. Some of the arrested have been denied bail. Surely even those who 'have committed crimes' deserve to be treated in a just manner. They cannot be denied their fundamental rights. Here the adage, 'justice delayed is justice denied,' rings true. Let us safeguard the human rights enshrined in our Constitution.

As we once appealed before the August 2023 elections, we urge our politicians again and those in government to exercise their duties responsibly. There is no need for the toxic, inflammatory rhetoric that is awash in the media. We would like to remind our politicians of the words of our Lord that, "To whom much is given; much will be required..." (Luke 12: 48). With the positions of leadership that you hold, you have been entrusted with much, and we ask you to use your positions of influence to animate all the people of Zimbabwe, including those who may disagree with your decisions and policies.

As the SADC summit draws near, we appeal to the law enforcers that they execute their duties professionally. It is prudent that investigations are done first and then crime perpetrators are arrested. It is never the other way round. As we prepare to welcome the SADC Heads of States, we implore all citizens to be law abiding, and to the government we insist on restraint. Together let us build a country where peace, justice and unity are the banners under which we rally.

As SADC leaders gather in Harare for their annual summit, Zimbabwe's government rounds up perceived "enemies of the state."

In theory, the Southern African Development Community, or SADC, aims to promote regional integration in order "to achieve economic development, peace and security, and growth, alleviate poverty, enhance the standard and quality of life of the peoples of Southern Africa, and support the socially disadvantaged." In practice, Zimbabwe's governing authorities are preparing to host the upcoming SADC summit by terrorizing political opponents, student activists, labor organizers, and community leaders—disrupting the peace and security of Zimbabwean citizens in a quest to silence anyone who might point out the way government corruption impedes economic development.

It's certainly true that Zimbabwe's government engages in repression as a matter of regular order; its record of documented human rights abuses is decades-long. But recently, President Emmerson Mnangagwa has been explicit in suggesting that his perceived political enemies wish to disrupt the summit, justifying the ratcheting up of draconian measures including torture, disappearances, and beatings of peaceful protesters in the name of being a good host. In his Orwellian telling, his government's violent crackdown will ensure tranquility.

Mnangagwa's position is as revealing as it is absurd. When he and his deputies speak about peace and security, they mean peace and security for themselves, not for the people of Zimbabwe as a whole. When they talk about prosperity, they are talking about enriching themselves, not the citizenry as a whole. They claim that opponents, activists, and whistleblowers are agents of shadowy foreign powers because they confuse their own interests with the national interest. Protecting their access to power and wealth is their entire *raison d'être*. Sadly, too many governments of SADC member states understand their purpose the same way. That's why they merely "noted" the substantial problems with Zimbabwe's last elections, and it's why they will feign ignorance of the campaign of terror unleashed in preparation for their visit to Harare.

One might imagine that the recent pivotal South African elections—which illustrated how popular discontent with corruption and unmet promises can dent the political power of even the most storied liberation party on the continent—would prompt reflection and reform in the region. But in Zimbabwe, the lessons learned have prompted the powerful to cling even more tightly to their privilege, and dole out punishment to the very people they claim to represent.

## **Statement: Alarming Escalation of State Repression in Zimbabwe Ahead of 44<sup>th</sup> SADC Summit**

Human rights and civil society organizations across the African continent are deeply concerned about the severe restriction of civic space and the systematic erosion of fundamental freedoms in Zimbabwe. The recent escalation in state-sponsored repression, characterized by abductions, arbitrary arrests and unjust denial of bail, torture, and harassment of human rights activists and opposition political members, represents a profoundly disturbing trend. This repressive environment

is particularly concerning ahead of the 44<sup>th</sup> session of the SADC Summit of Heads of State and Government scheduled for 17 August 2024. It constitutes a direct assault on the fundamental rights of Zimbabwean citizens and an egregious violation of democratic principles and international standards.

The recent brutal crackdown on the Zimbabwe National Students Union (ZINASU) exemplifies this escalating repression. On Wednesday, July 24, in Harare, ZINASU students peacefully convened for their annual General Council meeting when armed police in riot gear stormed the ZESA National Training Centre. The police violently disrupted the gathering, subjecting unarmed students to severe beatings and arresting several attendees, resulting in numerous injuries. ZINASU, a united front of Zimbabwean tertiary students, is dedicated to protecting students from exploitation and oppression, defending academic freedoms and rights, and promoting democracy.

This incident is not isolated but rather part of a broader and deeply troubling pattern of intimidation, arbitrary arrests, and victimization of civic groups and the opposition. Currently, over 77 democracy activists are languishing in pre-trial detention after the High Court denied them bail following their arrest for holding a peaceful meeting at a private residence in Harare. The detained members include children, elderly men, and women, some of whom were severely beaten and tortured while in custody. Previously, opposition politician Mr. Job Sikhala was detained for 595 days from June 2022, frequently denied bail, kept in leg irons, in solitary confinement, and often denied access to his lawyer and relatives. Obert Masaraure, president of the Amalgamated Rural Teachers Union of Zimbabwe (ARTUZ) has also been subjected to numerous long drawn-out criminal proceedings and pre-trial detentions and was recently convicted of the crime of Obstruction of Justice for an alleged tweet in solidarity with an arrested colleague. The judiciary and law enforcement agencies are being weaponized to prosecute and persecute political opponents, signalling an alarming escalation of domestic repression.

Moreover, there has been a disturbing rise in extrajudicial killings, forming part of state-sanctioned violence against activists. Following the controversial August 2023 elections, several opposition members were abducted, tortured, and killed, including political activist Mr. Tapfumaneyi Masaya, who was abducted, tortured, and murdered on November 12, 2023. These incidents highlight the ongoing injustices against defenceless citizens and the relentless shrinking of democratic space. Additionally, recent death threats issued by Zimbabwe's Information Minister, Mr. Jenfan Muswere, accusing the opposition and civil society organizations of planning to instigate chaos and subversive activities, further exacerbate fears. President Mnangagwa's remarks warning against "rogue elements" inciting civil disorder ahead of the SADC Summit underscore the state's intent to suppress dissent.

On 31 July 2024, pro-democracy activist Namatai Kwekweza, trade unionist Robson Chere, and former councillor, opposition member Samuel Gwenzi and Vusumuzi Moyo were apprehended and removed by suspected security service officers from a domestic flight headed to Victoria Falls for a civil society workshop. For at least eight hours they were held incommunicado, their whereabouts unknown to both family and lawyers. When their lawyers eventually accessed them, Robson Chere had been visibly tortured and was in great pain. During consultations with their lawyers all of them

reported being tortured and subjected to cruel inhuman and degrading treatment and punishment. They have now been absurdly charged with disorderly conduct in a public place.

We remind the Zimbabwean government of its obligations under article 4 of the SADC Treaty which requires its member states to act in accordance with the principles of human rights, democracy and the rule of law. Section 44 of the Zimbabwean Constitution mandates the respect, protection, promotion, and fulfilment of the rights and freedoms delineated in the Universal Declaration of Human Rights, including the right to freedom of assembly and association as specified in Section 58. These rights are also enshrined in international law and several binding regional instruments, including Articles 10 and 11 of the African Charter of Human and Peoples' Rights (African Charter), Article 8 of the African Charter, Articles 20 and 21 of the Universal Declaration of Human Rights, and Articles 21 and 22 of the International Covenant on Civil and Political Rights. These rights are central to Zimbabwe's constitutional democracy, providing a vital avenue for citizens to advance their objectives of promoting human rights and freedoms.

Gatherings of student unions, political parties and civil society organisations have never posed a security threat. We demand a clear and coherent explanation from the authorities for such heavy-handed actions, which only serve to heighten unnecessary security fears ahead of the SADC Summit.

#### CITIZENS COALITION FOR CHANGE CCC

Citizens, advocates of justice, members of the diplomatic corps and members of the public at large are reminded that their trial commences on Monday the 29th of July 2024. You are all implored and called upon to turn out in your numbers to offer your support and solidarity and to send a message to the government that weaponization of the law to punish and silence legitimate opposition leaders and human rights activists should and will not be a part of our political culture. In short, this is a call for local, regional and international solidarity to voice out our disagreement against the use of the law and justice system to prosecute political opponents.

Significantly, it is worth noting that the arrest of Senator Timba and others is not the only case of political arrest and persecution since the August 2023 disputed harmonized elections. A few days ago, more than 60 activists of the Zimbabwe National Students Union (ZINASU) were brutally and violently arrested including their National President Emmanuel Sitima. The statics below highlight the escalating and disturbing trend of political persecution, including 3 rape victims in Muzarabani, displacements including evictions by Chiefs of villagers in Muzarabani for supporting the alternative.

Presently, the top leadership of the alternative is under siege, either in detention, in hiding or one form of threat or the other. Many bare under threat of arrest and abduction for merely being members of the alternative. Several leaders report receiving anonymous calls threatening them. Church leaders who organized and submitted a petition in Zambia have been threatened and forced to flee their homes. Rampant Corruption, Rent-Seeking, Plunder and Pilferage.

The government of Zimbabwe has been the chief perpetrator of corruption, rent seeking and plunder of state resources, awarding lucrative contracts to themselves, their kith and kin and their cronies and proxies.

This is the root cause of the continued failure and regression of the national economy, pushing millions of Citizens into abject poverty and starvation. The partisan distribution of national resources extends to food distribution which has been highly politicized and weaponized against those perceived to hold opposition views. A prominent example is the late Mboneni Ncube's family who have been repeatedly been denied food. Mboneni was brutally murdered by suspected Zanu PF activists at an opposition campaign rally in Kwekwe. Several high profile corruption cases have been reported and exposed but no arrests have been made.

Mr. Wicknell Chivhayo who has been named in several high profile scandals remains not only scot-free but boastful that nothing will happen to him. We continue to vehemently denounce corruption and call on members of the public to report, expose and denounce corruption whenever and wherever it raises its ugly head.

#### Political and Institutional Illegitimacy

It is common cause that the August 2023 harmonized elections were fraudulently flawed and did not produce a legitimate and outright winner. This is acknowledged by all election observer missions, including SADC. This means that the government currently in place in Zimbabwe is illegitimate and not properly constituted in terms of the laws of the country, it is a de facto government. This is further exacerbated by the unlawful recall of our parliamentary and local government representatives elected on the same disputed elections. This has delegitimized the current parliament.

We insist on the reinstatement of our lawfully elected officials and the removal of the imposters imposed by Mr. Tshabangu and others in connivance with Zanu PF.

The weaponization and capture of the judiciary and the disputed Presidency of Mr. Mnangagwa means that Zimbabwe now suffers political and institutional illegitimacy.

The three key institutions of the state,

- namely the executive,
- the judiciary and
- the legislature

have been bastardized and delegitimized. It is our considered view that the coming of SADC into Zimbabwe is a welcome and rare opportunity to help foster a political solution to the Zimbabwe's

*"Citizen observers faced severe restrictions due to a shrinking space for civic activities, administrative barriers, pressure, consistent intimidation, and even mass arrests on election day. A raid took place on election night where some 40 members of key reputable citizen observer organisations such as Zimbabwe Electoral Support Network (ZESN) and Electoral Resource Centre (ERC), part of the internationally recognised Global Network of Domestic Election Monitors (GNDEM), were arrested for "coordinating the alleged release of election results". They were held without legal counsel for some 12 hours and, although released on bail, still face upcoming court proceedings."*

*"THE ELECTION RESULTS COULD NOT BE INDEPENDENTLY VERIFIED due to the absence of publicly available data, disaggregated by polling station, which is a key good practice, and the undermining of the sample-based projection of results that was to be conducted by citizen observer groups. Despite public rejections of the presidential outcomes by some opposition representatives, no contestant lodged a formal appeal against the election results. The post-electoral environment saw a further deterioration in the human rights situation, due to crackdowns on civil society, with certain human rights defenders and opposition figures targeted."*

### The Party Cells

The cell is the vanguard of the Party at the level of the village and the community, representing its [Zanu PF's] interest, expressing its aspiration and mobilizing the membership to work together for their area's development. Members of Cell Executive Committee hold Office for a period of one year. So the heart beat of the party is the Cell.

ZANU PF is people and people are ZANU PF are people *{this part makes little sense!}*.

### The Branches

The branch is made up of **ten cells**. Its Executive Committee is elected every two years at a Branch Conference by delegates representing each of the ten cells.

### The Districts

The district consists of **10 Branches** whose delegates elect the District Executive Committee once every two years.

### District Coordinating Committee (DCC)

The DCC consists of elected members from the branches who represent the **main wing, women's league** and the **youth league**.

### The Provinces

The province consists of as many Administrative Districts as there are in a Province and all Party Districts. Members of the Provincial Executive Council are elected at Provincial Conference by the delegates representing each Party district in the province. The provincial elections are held once every three years.

## The National Consultative Assembly

The National Consultative Assembly comprises members of the Central Committee, National Assembly of the Women's League and their deputies, the 10 provincial executive councils, former members of the Central Committee on account of their contribution to the liberation struggle **{more than 44 years ago – it's time this was updated}** or development of the country after independence **{an excuse to shoe-horn in those who Zanu PF wish to favour for monetary gain}**.

It receives, hears and debates any major matters of policy as the President and First Secretary or Central Committee shall from time to time determine **{it is a command structure – ED may listen but he will not hear – it is by definition a ruthless dictatorship top down only – except to punish those the Zanu PF leadership fear}** .

It also makes recommendations to the Central Committee on any matters of policy relating to the party or government. It meets at least twice a year.

## The Central Committee

The Central Committee is the principal organ of the Congress and consists of **230 members** drawn from the Party's country **10 Provinces**. It acts on behalf of Congress when it is not in session and among other things; implement all policies, resolutions, directives, decisions, and programs enunciated by Congress. The Central Committee meets once in three months.

## The Politburo

The Politburo is the standing Committee of the Central Committee and **IMPLEMENTS ALL THE DECISIONS, DIRECTIVES, RULES AND REGULATIONS OF THE CENTRAL COMMITTEE.**

It meets at least once a month and is answerable to the Central Committee on all matters.

The Patriotic Front (PF) was formed as a political and military alliance between ZAPU and ZANU during the war against white minority rule in Rhodesia (now Zimbabwe). **{again this 44 year history bears no relevance to the current day requirement and needs of the Zimbabwean population}**
